

Fitting with the 2025 strategies, much of the VSCPA's member programs focused on leadership development and innovation. The LEAD initiative continued on its successful path, picking up new partnerships with Dale Carnegie and Frontier Academy, and the new Innovation Advisory Council is laying the groundwork for the launch of the upcoming Center for Innovation.

We continue to focus on creating opportunities for members to meet each other and new business contacts, and held a dozen networking events throughout the state for members, many of which were in conjunction with colleagues in the real estate, law, financial planning, banking and insurance professions. Last year we brought together hundreds of professionals to create new business development

opportunities in regions across Virginia. Our Connect online community continues to be a strong peer-to-peer sharing platform, with more than 9,000 members signed up as of the end of 2017–2018.

As previously mentioned, nearly 600 members volunteered with the VSCPA this year across our boards, committees, task forces and community engagement opportunities. Fifteen of those volunteers served as ambassadors, an elite volunteer opportunity aimed at forging a link between the VSCPA and employers. Among other roles, those ambassadors — representing nine companies from three chapter areas — help with VSCPA presentations at staff meetings and intern trainings, promote VSCPA events and resources and help identify new volunteers.

We need your help to continue to build relationships and enhance the profession's reputation with new legislators who may not be familiar with the vital services CPAs provide.

### Advocacy

2017–2018 marked a year of transition for the Virginia General Assembly and the VSCPA's advocacy efforts. That transition manifested in markers both physical — the General Assembly office building was demolished to make room for a new building (more on that later) — and ideological, with Democrats flipping 15 seats in the House of Delegates, where power was determined by a drawing that decided a razor-thin election.

Those shifts forced the VSCPA to rethink some of its advocacy efforts and accelerated some shifts that were already happening. Because of the aforementioned office building demolition and the subsequent move to the smaller Pocahontas Building, the annual CPA Assembly Day event, where members descended upon the General Assembly office building en masse, became CPA Assembly Week, a more targeted event with members visiting legislators by appointment to help promote CPAs and the issues closest to the profession.

The changing nature of the event and the parade of new faces in the House mean that relationships are more important than ever for the VSCPA's advocacy efforts. In addition to CPA Assembly Week, one major component of our advocacy work is getting members in front of legislators in their own districts.

The VSCPA's longstanding advocacy efforts have established a strong reputation for the Society in Richmond. In addition to staff leadership, our strong group of experienced advocacy volunteers enhances that reputation. But we want to continue to grow those relationships in legislators' home districts, and that's where we need help from more members, particularly outside of Richmond.

In 2017–2018, those efforts were aimed at two main issues: Tax reform and the Virginia Board of Accountancy's (VBOA) move to a uniform license renewal date. Both were dealt with in the 2018 Virginia General Assembly session. The VSCPA supported bills on both issues and got them to the desk of Gov. Ralph Northam, who signed them into law. The renewal date bill was relatively straightforward, setting the VBOA up for a uniform renewal date of June 30 beginning in 2019.

Conformity was tricky in 2018 because of the large number of freshman legislators and the complicated messaging necessitated by the passage of federal tax reform. The bill, focused solely on changes impacting 2017, also had to be amended after initial passage to include several extender provisions affecting 2017 returns that were included in federal budget legislation. However, the VSCPA helped shepherd it through the General Assembly and will continue to actively engage on the issue heading into the 2019 session.

### Learning

One word comes to mind when assessing the VSCPA's learning initiatives in 2017–2018: Agile. Being able to react quickly to trending topics is top of mind. As soon as the Tax Cuts and Jobs Act became law, the VSCPA had planned a round of updates with tax expert Don Farmer. The supplementary Farmer events, held Jan. 29 and Feb. 1, provided more than 600 CPAs the most up-to-date information from a nationally known expert. We supplemented those offerings with further online courses and partners. That "just-in-time learning" has become a VSCPA hallmark, with timely education on employee benefit plan audits held at our Virginia Accounting & Auditing Conference and numerous offerings on cybersecurity, fraud and cryptocurrency. Peer-to-peer learning is another focus through our social lounges at in-person events, which allow a relaxed opportunity to share tips and best practices with your professional colleagues.

The VSCPA ended the 2017-2018 membership year with 4,236,285 in net assets, representing an increase of \$422,614 from 2016–2017. Current VSCPA assets amount to \$5,581,799 with current liabilities of \$1,345,514.


Continuing education made up 54 percent of VSCPA program revenue, with membership programs accounting for another 40 percent. Educational programs accounted for 41 percent of expenses, with membership making up

12 percent and leadership making up another 9 percent. Administrative and general expenses made up 16 percent of total expenses.
